In the Special Meeting of the Shareholders of Melco Crown (Philippines) Resorts Corporation (the "Corporation"), held today, October 8, 2013, the following amendments to the By-laws of the Corporation were approved:

- (a) Amendment to Article II, Section 7 of the By-laws to provide that directors, as such, shall receive compensation for their services. Such compensation shall be determined and apportioned among the directors in such manner as the Board may deem proper, and will be ratified by the stockholders representing at least a majority of the outstanding capital stock;
- (b) Amendment to Article III, Section 5 of the By-Laws to amend the functions and duties of the President of the Corporation; and
- (c) Amendment to Article III, Section 6 of the By-Laws to include a section on the office of the Chief Operating Officer ("COO") of the Corporation and provide for the functions and duties of the COO.
