DISCLOSURE

Melco Crown (Philippines) Resorts Corporation (the "Corporation") hereby discloses that its controlling shareholder, Melco Crown Entertainment Limited ("MCE"), with its shares listed on the Main Board of The Stock Exchange of Hong Kong Limited (the "Hong Kong Stock Exchange") and its American depositary shares listed on the NASDAQ Global Select Market, filed its financial results for its fourth quarter ended 31 December 2013. Such filings include segment financial information of City of Dreams Manila ("COD Manila"):

- 1) On a fully consolidated basis from MCE perspective, COD Manila incurred approximately US\$8.3 million of operating expenses in the fourth quarter of 2013, which primarily relate to pre-opening costs as well as share based compensation cost, and recorded a net loss of approximately US\$18.2 million as a result of approximately US\$10.1 million of capital lease charges relating to building lease payments incurred during the fourth quarter of 2013;
- Total cash and bank balances of COD Manila as of 31 December 2013 totaled US\$244.5 million. As at 31 December 2013, the capital lease obligations was US\$280.3 million;
- 3) Capital expenditures for COD Manila for the fourth quarter of 2013 were US\$33.4 million; and
- 4) In January 2014, MCE Leisure (Philippines) Corporation, a subsidiary of the Corporation successfully completed a Philippine Peso denominated, US\$340 million equivalent, 5% senior note offering with proceeds primarily used to design, construct and operate COD Manila.

MCE filed its unaudited financial results of the fourth quarter and year ended December 31, 2013 with the Hong Kong Stock Exchange and the United States Securities and Exchange Commission today, 13 February 2014.

It should be noted that the financial results of MCE and its consolidated subsidiaries. including those contained in the quarterly financial results and condensed consolidated financial information have been prepared in accordance with the generally accepted accounting principles of the United States ("US GAAP"), which are different from the Philippine Financial Reporting Standards ("PFRS") that the Corporation is subject to when preparing and presenting its consolidated financial results and related financial information. This may result in differences between the figures presented herein, which represent the segment of COD Manila from the perspective of MCE. The segment results and financial position of COD Manila from MCE perspective may be different from the figures which may subsequently be contained in any financial statements of the Corporation. Furthermore, the financial results and related information set forth in the quarterly financial results and condensed consolidated financial information are not directly comparable to the financial results and related financial information that would otherwise be disclosed by a company which shares of its stock are traded on the Philippine Stock Exchange. As such, the public is advised to exercise caution when dealing with the securities of the Corporation based on the figures presented above.
