## CITY OF DREAMS MANILA OFFICIALLY OPENS

*Thrilling entertainment-inspired integrated resort will

**MANILA – Monday, February 2, 2015:** (1.30 p.m) Today, City of Dreams Manila officially became a reality. A press conference was held to mark the official grand launch of the integrated gaming and entertainment resort, set to become the “must experience” destination in Manila.
