DISCLOSURE

On 4 May 2015, the Philippine Amusement and Gaming Corporation (“**PAGCOR**”) issued in favor of MCE Leisure (Philippines) Corporation (“**MCE Leisure**”), as the special purpose entity and the operator of City of Dreams Manila, and its other co-licensees the regular casino gaming license (“**Regular License**”) for the operation of City of Dreams Manila, after satisfying the requirements under Article IV Section 2 of the PAGCOR provisional license dated 12 December 2008.

MCE Leisure is an indirect wholly-owned subsidiary of Melco Crown (Philippines) Resorts Corporation.

City of Dreams Manila commenced operations on 14 December 2014 and applied for the issuance of a regular casino gaming license with PAGCOR on 30 January 2015. The Regular License has the same terms and conditions as the PAGCOR provisional license and is valid until 11 July 2033.
